to report child abuse:**

California, Colorado; Pennsylvania (as health professional if comes into
contact with child in course of profession)

Veterinarians Mandated to Report Animal Cruelty:

Alabama, Arizona, California, Colorado, Illinois, Kansas, Maine (only aggravated cruelty), Maryland, Massachusetts, Minnesota, Missouri, Nebraska, North Dakota, Oklahoma, Oregon, Pennsylvania (if committed by another veterinarian), West Virginia, Wisconsin

Veterinarians Permitted to Report Animal Cruelty:

Arkansas, Florida, Georgia, Idaho, Indiana, Maine (cruelty and neglect), Michigan, Mississippi, Nevada, New Hampshire, New York, North Carolina, Rhode Island, Texas, Utah, Vermont, Virginia (veterinary technicians as well), Washington

Veterinarians Prohibited from Reporting Animal Cruelty

Kentucky

Nothing Specified Regarding Veterinary Reporting:

Alaska, Connecticut, Delaware, Hawaii, Iowa, Louisiana, Montana, New Jersey, New Mexico, Ohio, South Carolina, South Dakota, Tennessee, Wyoming

Reporting Elder Abuse/Neglect

**Animal Care & Control
MANDATED to report elder abuse:** Arkansas (animal welfare officers), California, Maine (humane agents)

**Animal Care & Control
PERMITTED to report elder abuse:** Maine (animal control officers)

Veterinarians mandated to report elder abuse: Illinois

EVERYONE is a mandated
reporter of elder abuse:** Missouri, New Hampshire, New Mexico, North Carolina, Rhode Island, Utah, Wyoming
