### A Resource-Rich Website



# Our Accomplishments

Since our team first raised LINK awareness in the 1980s, our information has been widely used to protect vulnerable animals, children, and adults.

### **Criminal Justice**

- The FBI now includes animal cruelty in its national crime data collection system.
- National and international law enforcement associations support animal cruelty investigations to protect public safety.
- Bench cards advise family court judges to consider animal abuse in the context of juvenile offenders, protection orders, and divorce settlements.
- Specialized animal cruelty task forces have been formed in 54 law enforcement agencies and prosecutors' offices in 21 states.
- We have helped create LINK-based Technical Assistance resources for:
  - Association of Prosecuting Attorneys
  - American Prosecutors' Research
     Institute
  - National Council of Juvenile and Family Court Judges
  - American Bar Association
  - U.S. Department of Justice.





### Domestic Violence (DV)

- Over 300 DV shelters are now pet-friendly.
- Manuals in 35 states assist DV advocates to help survivors obtain protection orders for their pets.
- Dozens of studies examine how threats to animals impede abused women and children from escaping dangerous relationships.

### **Child Maltreatment**

- The UN recognizes children have a right to be free from exposure to animal cruelty.
- Awareness that children's perpetration or witnessing of animal cruelty is an Adverse
   Childhood Experience with lifelong behavioral and physiological consequences.
- Cross-reporting templates help child protective workers recognize and report animal cruelty and humane officers recognize and report child maltreatment.

#### Elder Abuse

- The National Adult Protective Services
   Association created the Research-to Practice brief about animal abuse.
- Protocols and Technical Assistance manuals assist Adult Protective Services caseworkers to screen for animal cruelty and hoarding.





### **Veterinary Medicine**

 Veterinary associations around the globe encourage or require veterinarians to report suspected cases of animal cruelty with civil and criminal immunity.

### Legislation

- Animal cruelty is a felony in all 50 states and federally, compared with 5 in 1992.
- 49 states prohibit sexual assault of animals, due in part to its LINK with child pornography and child sexual abuse.
- 42 states require or explicitly allow veterinarians to report suspected animal abuse.
- 40 states explicitly allow courts to include pets in domestic violence protection orders.
- 16 states require or explicitly allow crossreporting between child protection, animal protection and adult protective services.
- 12 states define animal abuse as an act of domestic violence.
- The federal Pets And Women Safety
   (PAWS) Act of 2018 allows states' pet
   protection orders to be enforced interstate
   and offers \$3,000,000 to help domestic
   violence shelters accept pets.
