# Reporting by CHILD PROTECTION/DCF/SOCIALWORKERS

CPS/DHS/Social Workers MANDATED

to report animal abuse

Connecticut, Delaware, D.C.\*, Florida\*, Illinois\*, Louisiana, Nebraska, Ohio\*\*, Tennessee, West Virginia\*

CPS/DHS/Social Workers PERMITTED to report animal abuse California, Indiana, Maine, Massachusetts, Oregon Guam (social workers)

### Reporting by ANIMAL CARE AND CONTROL OFFICERS

Animal Care/Control MANDATED to report child abuse/neglect

California, Colorado, Connecticut\*\*, D.C.\*, Florida\*, Illinois\*, Maine (if a law or code enforcement official or humane agent), Massachusetts, Ohio\*\*, Oregon, Virginia, West Virginia\*

Animal Care/Control PERMITTED to report child abuse/neglect

Animal Care/Control MANDATED to report elder/disabled abuse

Arkansas, California (if employed by law enforcement agency), D.C., Maine (humane agent) Massachusetts, Ohio\*\*, West Virginia

# Reporting by ADULT/DISABLED PROTECTIVE SERVICES

Adult Protective Services
MANDATED to report animal abuse

Louisiana, Nebraska, Ohio, Tennessee, West Virginia Guam

Adult Protective Services
PERMITTED to report animal abuse

California, Indiana, Maine, Massachusetts, Oregon

<sup>\*</sup> States with full two-way cross-reporting between child protection/animal control-humane. No data exist on utilization or enforcement.

<sup>\*\*</sup> Connecticut and Ohio animal control officers report suspected animal abuse to the Department of Children and Families, which then cross-references these reports with their own case files. Ohio officers must report suspected animal abuse to the Department of Job & Family Services if a vulnerable adult is at the residence.

# Reporting by VETERINARIANS

#### **Veterinarians Mandated to Report Animal Cruelty:**

Alabama, Arizona, California, Colorado, Connecticut (animal fighting) Hawai'i, Illinois, Kansas, Maine (only aggravated cruelty), Maryland, Massachusetts, Minnesota, Missouri, Nebraska, New York, North Dakota, Ohio (companion animals), Oklahoma, Oregon, West Virginia, Wisconsin. Also Guam (animal fighting).

#### **Veterinarians Permitted to Report Animal Cruelty:**

Alaska, Arkansas, Florida, Georgia, Idaho, Indiana, Kentucky, Louisiana, Maine (cruelty and neglect), Michigan, Mississippi, Nevada, New Hampshire, New Mexico, North Carolina, Pennsylvania, Rhode Island, Tennessee, Texas, Utah, Vermont, Virginia (also veterinary technicians), Washington.

#### **Veterinarians Mandated to Report Child Abuse/Neglect:**

California, Colorado

#### **Veterinarians Mandated to Report Elder Abuse:**

Colorado, Illinois

#### **Nothing Specified Regarding Veterinary Reporting:**

Delaware, Iowa, Montana, New Jersey, South Carolina, South Dakota, Wyoming

# Universal Reporting of Child Abuse/Neglect

States in which reporter of child abuse:

Delaware, Florida, Idaho, Indiana, Kentucky, Maryland, Mississippi, **EVERYONE is a mandated** Nebraska, New Hampshire, New Jersey, New Mexico, North Carolina, Oklahoma, Rhode Island, Tennessee, Texas, Utah, Wyoming

# Universal Reporting of Elder Abuse/Neglect

States in which **EVERYONE** is mandated to report elder abuse:

Delaware, Florida, Indiana, Kentucky, Louisiana, Mississippi, New Hampshire, New Mexico, New York, North Carolina, Oklahoma, Rhode Island, Tennessee, Texas, Utah, Wyoming, Puerto Rico

# **Health Care Professionals Reporting of Domestic Violence**

Medical and healthcare professionals mandated to report domestic violence or sexual assault

California, Colorado, Kentucky, North Dakota, Oklahoma, Tennessee

Medical and healthcare professionals mandated to report injuries resulting from a crime or offense of violence

Florida, Idaho, Illinois, Iowa, Nebraska, New Hampshire\*, Ohio,

Oregon, Pennsylvania\*, West Virginia, Wisconsin

\* Medical personnel not required to report if victim does not give consent
